Company with office in Wrocław at ul. Sołtysowicka 13-15, postal code 51-168, entered in the register of entrepreneurs of the National Court Register maintained by VI Commercial Division of the District Court for Wrocław - Fabryczna under KRN no. 0000066712, with share capital of 7,833,084.10 PLN paid full; NIP no.: 895-16-86-107; Regon no.: 932093253 (hereinafter "the Company") of 23rd May 2011 (hereinafter "the Regulations of Supervisory Board"), hereby:

1. agree to appoint me for the position of a member of Supervisory Board of the Company for the new term by the Ordinary General Shareholder Meeting of the Company convened on 29th June 2017.

3. Under § 2, s. 3 of the Regulations of the Supervisory Board I declare that I meet the criterion of independence determined in the Company's Statute and § 3 of the Regulations of the Supervisory Board, i.e.:
 - a) I do not function and have not functioned in the past 5 years as a member of the Management Board of TOYA S.A. or its affiliate;
 - b) I am not and have not been in the past 3 years an employee of the Company or its subsidiary or affiliate,
 - c) I do not receive and have not received additional remuneration in a significant amount from the Company or its affiliate aside from the remuneration received as a member of the Supervisory Board;
 - d) I am not a Shareholder possessing 5% or more of total votes on the General Shareholder Meeting of the Company and I do not represent in any way controlling Shareholder(-s).
 - e) I do not maintain and have not maintained in the past year significant trade relations with the Company or its affiliate, directly or as a partner, shareholder, manager, or a high level employee of a body maintaining such relations.
 - f) I am not and have not been in the past three years a member or employee of the current or previous auditor of the Company or its affiliate;
 - g) I am not a member of the Management Board in another company, in which another Management Board member is a member of Supervisory Board, and I do not have any other significant relations with the executive managers of the Company by partaking in other companies or authorities;
 - h) I have not functioned in the Supervisory Board of the Company for longer than three terms or longer than 12 years;
 - i) I am not a member of a close family of the Management Board's members or any other persons indicated in § 3, s. 1, let. a) to h) of the Regulations of the Supervisory Board.

j) I am not an employee of the Company or its subsidiary or affiliate.
